We will be canoeing along the Seneca-Cayuga Canal with Bryan Schoeffler, head of the Christian Camping Services in Bath, NY. We plan on leaving the church parking lot, Friday July 16th, at 5pm. We will have dinner upon arrival at the cabin, where we will also sing songs and have a devotional.

Our canoe trip will start at Waterloo and will end near the north end of Cayuga Lake. Along the trip, we will go through 3 locks. We will break for lunch and have another devotional. There will also be time to stop and swim and have fun in the water.

It is **\$15.25 per person** to attend.
